CALL MEETING TO ORDER-The opening meeting statement was read, and the Town Board of Supervisors monthly meeting was called to order at 8:03am by Chairman Mohr at the Town Hall. The meeting agenda notice was properly posted.

1. Archies monthly progress report- Discussion was had regarding the last 30 days at Archies. Krumrei stated they might try a couple more and there wasn't a rush to purchase a new mower. Time was cut almost in half for cutting the Park lawn when 2 mowers were used.
4. Discuss Pickleball Court- Krumrei discussed the Pickleball Court progress.
5. Discussion of future Ordinances- Paape discussed how far along she is with the Code of Ordinance book along with Ordinances she is working on. She asked other Board members to get her something regarding a Park Ordinance by August 7<sup>th</sup>, 2023.
6. Review and modify Park Fee Schedule- Item was discussed and will be placed on next working meeting agenda.
7. Ordinance No. 1-2023 Five Member Town Board- Discussion was had with the Board members on having a Five Person Board. It was decided to have the Town Electors vote on a Five Person Town Board at the Annual Meeting in April. Krumrei motioned to accept Ordinance No. 2-2023, second by Paape. Approved by unanimous vote.
