APPROVAL OF MINUTES OF PREVIOUS MEETING(S)-

Paape motioned to approve December 11, 2023, minutes as is, seconded by Krumrei. Approved by unanimous vote.

1. Little Suamico Fire Department Report- Chief Zuge was absent. Brian Virtues went over the monthly calls. Virtues also talked about the annual fishing derby that is coming up in February.
2. Community Policing Report- Deputy Baeten- Deputy Baeten was absent. Copies of the monthly report were available.
3. Town of Pensaukee Road maintenance and snow removal written agreement adoption with Town of Little Suamico- Chairman Mohr briefly went over the agreement as it has been on two prior agendas. Paape motioned to approve the 5-year agreement, seconded by Krumrei. Approved by unanimous vote.
4. Campview Drive discussion of concerns and possible steps to be taken to mitigate problems. Public Comment- 2 Minutes- Chairman Mohr discussed Campview and then opened it up for Public Comment.

1. Did/Do the property owners know the road existed prior to purchase?
 2. Can the Town get the rules clarified from Brown County Parks?
 3. Can we just vote/or make a motion that the Town of Little Suamico does not consider a discontinuance of Campview Drive and force the adjacent landowners to petition for discontinuance of Campview through Oconto County Zoning.
 4. Can the Town's property be established into a park?
5. Union Lane dedication of road right of way and delineation of ownership. Public Comment- 2 Minutes- Chairman Mohr discussed Union Lane and that Brain Begotka is willing to dedicate the road right of way to the Town. Steve

Beida was also in attendance to discuss road dedication. Public Comment was opened.

6. Rezone request from R1 to RR for lots along east side of Union Lane discussion and action from previous Town Board and Plan Commission mtgs- Deliberations with Town Board. Paape motioned to allow rezone to move forward for parcels listed seconded by Krumrei. Approved by unanimous vote.
7. Special Committee updates: committee on storage units -Committee Chair Rod Duesing; Park Commission - Supervisor Krumrei; Community Building/Library - Supervisor Paape- Information was given from Chair Rod Duesing, Supervisor Krumrei and Supervisor Paape.

Frank Nowak was out of order and needed to be escorted out by Lieutenant Angus with Oconto County Sheriff's Department at 7:48pm.

8. Park Special Committee- Establish members to temporarily hold positions of an advisory park committee to the Town Board to guide the decision making on projects and budgets. Membership will be appointed until Town Park Commission is established at the annual meeting and subsequent park commissioners are appointed by the Town Board Wisconsin Statutes 60.66- Supervisor Krumrei discussed that he has 7 members and 1 alternate for the Park Committee.
