APPROVAL OF MINUTES OF PREVIOUS MEETING(S)-

4/8/24 Minutes- Paape motioned to approve minutes, seconded by Krumrei. Approved by unanimous vote.

Correspondence- Chairman Mohr asked if anyone had correspondence and supervisors stated they had none.

1. Little Suamico Fire Department Report- Chief Zuge reported there were 15 calls in April. Zuge mostly spoke on the car accidents and the snowstorm in April. The fire department did propane tank training in May, and they received a grant that pays for the entire training.

Owner/Petitioner for parcel(s) 024-081401232A – 1465 E Frontage Road - Request for a Rezone from A (Agriculture) to GC (General Commercial) to combine lots and plan to build a showroom, located in part of the NW ¼ of the SW ¼ of Sec 14, T26N, R20E- The Town Board reserves the right to permit nearby property owners that have received a letter from the Town the opportunity to speak on this topic for two (2) minutes- Kevin Bartlett was present and discussed the project. Chairman Mohr asked if there were any adjacent property owners that wanted to speak, there were none. The Town Board then went into deliberations. Paape motioned to approve the rezone, seconded by Krumrei. Approved by unanimous vote.

Owner/Petitioner for parcel(s) 024-061200521 – 1932 Herford Road - Requests a Land Division to create a 1.754-acre lot from 37.27 acres, located in part of the NE ¼ of the NE ¼ of Sec 12, T26N, R20E- The Town Board reserves the right to permit nearby property owners that have received a letter from the Town the opportunity to speak on this topic for two (2) minutes- Pat Virtues was in attendance to discuss the Land Division. Chairman Mohr asked if there were any adjacent property owners that wanted to speak, there were none. The Town Board went into deliberations. Paape motioned to except the CSM with no objections on the outcome contingent on Agenda Item number 5, seconded by Krumrei. Approved by unanimous vote.

Owner/Petitioner for parcel(s) 024-061200521 – 1932 Herford Road - Requests a Rezone from A (Agriculture) to R1 (Single Family) located in part of the NE ¼ of the NE ¼ of Sec 12, T26N, R20E - The Town Board reserves the right to permit nearby property owners that have received a letter from the Town the opportunity to speak on this topic for two (2) minutes- Pat Virtues was in attendance to go over the Rezone. The Town Board then went into deliberations. Krumrei motioned to accept to change the property from A

- (Agriculture) to R1 (Single Family) and send to Oconto County, seconded by Paape. Approved by unanimous vote.
6. Approval of Bills- Paape motioned to approve the bills, seconded by Krumrei. Approved by unanimous vote.
 7. Announcements/General Information- Krumrei talked about Air B&B's and that the Town nor the County have any real enforcement over people using their homes for rentals.
