CALL MEETING TO ORDER-The opening meeting statement was read, and the Town Board of Supervisors monthly meeting was called to order at 6:01pm by Chairman Mohr at the Town Hall. The meeting agenda notice was properly posted.

### BUSINESS:

1. Little Suamico Fire Department Report- Chief Zuge went over his report and discussed the Vehicle Replacement Plan the previous Town Board implemented in 2020 due to the trucks being all over 25 years old. Chief Zuge was able to get at least 4 bids for new fire trucks that he gave to the current Town Board. Paape stated that this should be a standing agenda item as current board was unaware of the replacement plan.
2. Community Policing Report- Deputy Baeten went over his report and answered a few questions.
3. April De La Ruelle from Lena Public Library gave a presentation on how residents of Little Suamico can get library cards and membership to the Lena Library. April gave a verbal presentation regarding the Oconto County Library system and what they have to offer to the Town of Little Suamico residents. She answered a few questions from Town residents.
4. Confirmation of Doug Allen to Plan Commission to fill vacancy- Chairman Mohr went over Doug Allen's qualifications for the Plan Commission and stated there was a vacancy to fill that had been posted. The only applicant for the vacancy Doug Allen. Paape motioned to accept Mr. Allen onto the Plan Commission, seconded by Mohr. Approved by unanimous vote.
5. Adoption of UDC (Uniform Dwelling Code) Ordinance- This ordinance defines the role of the town's building inspector and defines how costs are to be set up. Based upon the state laws and requirements for Uniform Dwelling Codes and enforcement steps when a town has its own building inspector. Chairman Mohr went over the reason for the updated UDC Ordinance. Paape motioned to accept the adoption of the UDC Ordinance, seconded by Mohr. Approved by unanimous vote.
6. Code of Ordinance discussion- Many residents gave concerns and comments regarding Ordinances for the Town. It was suggested by one resident to start a committee to work on the Ordinances with Liz for the Town of Little Suamico. A sign-up sheet was passed around and given to Supervisor Paape to begin the Committee process.

7. Firearms Discharge Ordinance- This is for discussion only and no action will be taken on it this evening. Public feedback is encouraged. This ordinance mirrors adjacent towns within Oconto County. There were many that spoke out against this Ordinance and a great deal of discussion was had between residents and the Town Board. The Town Board agreed to take the Firearms Discharge Ordinance out of the Code of Ordinance Book and they plan to make the motion at the October meeting.
8. Approval of Bills- Paape motioned to approve the bills, seconded by Mohr. Approved by unanimous vote.
