After discussion this topic was tabled until next meeting date.
4. Information regarding kayak launch- Jessica received grant information regarding the kayak launch and this will be a continual topic on our agendas.
5. Proposal from Cedar Corporation- The Commission looked over the quote from Cedar Corporation and it was decided that for now we do what we can from using the SOLO maps on the Oconto County website instead of spending the money.
6. Review quote on woodchips- Tracey went over the quote for woodchips from a company that is doing other municipalities, and it was decided to not get woodchips at this time.
7. Announcements- Tracey stated that the pickleball nets are down and restrooms are closed for the winter. He also asked to possibly change around the food area.
