Kerie Karls, Chairperson for the Park Commission is sick, and Chris Hillberg stated he would be Chairperson for the meeting. Jessica motioned to approve Chris to be Chairperson, seconded by Todd. Approved by unanimous vote with Chris abstaining the vote.

CALL MEETING TO ORDER- Chris called the meeting to order at 4:30pm. The meeting agenda notice was properly posted.

APPROVAL OF AGENDA- Lisa made a motion to approve, seconded by Todd. Approved by unanimous vote.

BUSINESS:

1. Review the Ice Rink- Lee and Tracey went over the ice rink and that there are some troubles with removing all the snow from the rink. They have also noticed some people using the rink.
2. Recycling Bins- Lisa got bids for blue recycling bins to match the green garbage bins at the park. Total cost for 2 bins would be \$253.98. Jessica made a motion to purchase 2 recycling bins for the park, seconded by Tracey. Approved by unanimous vote.
3. SOLO map of Park- Lisa provided members with a map of the park and had one larger one for all members to combine their ideas. Lisa received the map from Jamie Broehm, and he stated he would be able to add things to the map as we add things to place into the park plan.
4. Signs for walking trails- The distance was not figured out to place on the signs, so this was tabled until next meeting.
5. Installation of old sign from Town Hall- Tracey spoke of putting up the old sign from the Town Hall at the park and getting a new sticker to place on it. He will be bringing in cost of new sticker to next meeting. Discussion was had by all members on how to place the poles and if cement or just gravel would be needed. Tracey will be bringing in costs for poles and cement or gravel to next meeting.
6. Installation of new basketball hoops- Tracey will be getting bids for new backstops for basketball hoops at the park. The court will remain the same.
7. Review hours for ice skating rink including lights- Lisa read information she received from Wisconsin Towns Association regarding if the Park Commission can set times for ice rink and lights being on. Chris discussed a timer that could be placed. IT was decided to leave as is for this year to see how much rink is used.
8. Review Park Ordinances- Tabled until next meeting when everyone is in attendance and Lisa will ask John Link and Liz Paape to come to the meeting.
9. Announcements- Jessica stated she has a call into DNR regarding kayak launch grant. Todd talked about possibly removing fence and asked if there are any plans for baseball field number 3. Tracey spoke on the possibility of Little League playing/practicing at the park this Spring/Summer.
