Meeting called to order at 11:00 A.M. by Chairman Mohr. Mohr read the opening meeting statement. The agenda was properly posted to notice the meeting.

Approval of Agenda

Pribyl moved to approve the agenda as presented, seconded by Krumrei. Motion carried, voice vote.

- 1. Discuss and Approve the Yard Waste Plan- Krumrei went over the proposed yard waste plan with some unknowns until it is up and running. There would be a \$30.00 fee per year for Town of Little Suamico residents only. The short-term plan is to have the waste dropped on the Southeast corner inside the fence. Residents will be given a card to bring each time they want to dump so Town knows they have already paid the \$30.00 fee. Fee also aligns with Town of Chase's fee. Krumrei hopes to eventually have a compost pile that can be utilized by the Town residents. Pribyl stated he had spoken with Dan Kroll with the DNR and mentioned Dan told him the following would be needed.
 - \$500 permit fee to have the yard waste
 - \$1650.00 fee if the Town planned to have the yard waste dumped on the area where the previous landfill was, and that area would also need to be graveled or blacktopped.

Pribyl also mentioned that the North fence is on Dennis Leja's property so this should be investigated soon. Discussion was had with the Town Board members, and they all felt that it needs to be open, and they called Dan with DNR hoping for call back to get the ok to open on Saturday.

Helmle motioned to open Saturday May 3rd, Saturdays only from 7:30am-12pm and look to readjust more time if needed in the future, seconded by Pribyl stating it needs to be dumped on the pad and that way if DNR did not grant the permit it can be removed. Approved by unanimous vote. Krumrei asked to open for discussion with residents at the meeting. After discussion, Helmle moved to amend her motion to include putting license plate numbers on the sign in sheet and on the card, residents are giving, seconded by Krumrei. Approved by unanimous vote.

- 2. Approval of Resolution- R2025-4- Fee Schedule- Motion was made by Krumrei to approve the resolution, seconded by Pribyl. Approved by unanimous vote.
- 3. Approval of Resolution- R2025-5- Recycling Center Fee Schedule- Helmle motioned to approve the resolution, seconded by Krumrei. Approved by unanimous vote.
