CALL MEETING TO ORDER-The opening meeting statement was read, and the Town Board of Supervisors monthly meeting was called to order at 6:00pm by Chairperson Mohr at the Town Hall. The meeting agenda notice was properly posted.

- 1. <u>Little Suamico Fire Department Report</u>- Chief Zuge went over the four calls for the month of May. Chief Zuge stated Oconto County has offered free Narcan kits to the municipalities in the County, the Town has requested two and will at least receive one when they are available. August 5th is National Night out and will be held at the Town Park from 5-8pm.
- 2. <u>Community Policing Report</u>- Deputy Baeten was present, his report was available to take at the entry table. He mentioned that violent crime was up for the month of June. He also spoke about National Night out.

Lot 1 of proposed CSM will be used for a residence and Lot 2 will stay the same for current use. THIS REQUEST WAS NOT NEEDED FOR THE LAND DIVISION/REALIGNMENT, the Town will refund the funds for this request.

Helmle motioned to approve the Rezone, seconded by Pribyl, approved by unanimous vote. A comment was made by Frank Nowak.

Pribyl motioned to approve the Conditional Use Permit for a future coffee shop, bakery, ice cream shop, candy store, or chocolate shop, seconded by Krumrei, approved by unanimous vote.

 (Agriculture) to PR (Park/Rec) REMOVED FROM AGENDA
- Owner/Petitioner for parcel 024-010702434 located in Section 07, T26N, R20E- 7142 Lower Road for a Conditional Use Permit -REMOVED FRON AGENDA
- 10. Park Commission Report Chairperson Karls was not present. Helmle reported on resurfacing of the Pickle Ball Court. National Night out will be held at the park on August 5th from 5-8, there will be food and games. The Kayak launch delineation is in progress. The Friends of the Park (FOP) have received a grant and are working on having new ADA accessible playground equipment installed, it should be done in August. The FOP will also write two additional Grants for playground equipment. Mohr mentioned that there has been some vandalism at the park and Officer Baeten has found one of the offenders.
- 11. Ordinance Committee Report- John Link spoke regarding progress being made on reviewing the Ordinances.

- 12. <u>Approval and Adoption of removal of the rescinded sections of Chapter 3</u>. John Link from the Ordinance Committee stated he has a meeting with the Town's Attorney on Friday to discuss the changes to Chapter 3 and should have the final proposal for the Board at the August meeting.
- 13. <u>Approval for Temporary 2025 Alcohol Beverage License</u>. A motion was made by Pribyl and seconded by Helmle to approve the Temporary Alcohol Beverage License for the St. Maximilian Kolbe Church Picnic. Approved by unanimous vote.
- 14. <u>Approval for Temporary 2025 Alcohol Beverage License</u>. A motion was made by Helmle and seconded by Pribyl to approve the Temporary Alcohol Beverage License for the Friends of the Park, Little Suamico Days. Krumrei abstained, approved by majority vote.
- 15. <u>Approval for Temporary 2025 Alcohol Beverage License</u>. A motion was made by Helmle and seconded by Pribyl to approve the Temporary Alcohol Beverage License for the St. John's Church Picnic. Krumrei abstained, approved by majority vote.
- 16. Accept the Plan Commission's recommendation to approve the Highway 41/141 Corridor Study. Discussion was had. A motion was made by Pribyl and seconded by Helmle to accept the Plan Commission's recommendation to approve the Highway 41/141 Corridor Study and take the next steps to add it to the Town's 20-year Comprehensive Plan. Approved by unanimous vote.

- 17. Road Grading Plan- Discussion was held regarding the state of Rost Road. Chief Zuege commented in the event an emergency vehicle had to use that road it would take a very long time as the road can only be traveled at about 2mph, due to the condition. A Point of Order was called by John Link (reason Mr. Link was under the belief that you could not bring up an action that was addressed at the prior meeting Mohr made a determination that it could be done and called for Motion). A motion was made by Pribyl to get bids to grade ONLY Rost Road, to include gravel, rolling, and scarifier, seconded by Krumrei. Approved by unanimous vote. After the meeting the Town Association was contacted by the Town Clerk, Lisa Glinski, and they confirmed that the action by the Borad was correct.
- 18. <u>Approval of Bills</u> Motion was made by Pribyl to approve bills as presented, seconded by Krumrei. Approved by unanimous vote.
- 19. Announcements/General Information/Supervisor Comment Chairperson Mohr mentioned that he had spoken with Mr. Dennis Leja regarding the lot lines at the Recycle Center. Mr. Leja stated he has no concerns about the lines and the Town can continue to operate as usual at the Recycle Center. Supervisor Pribyl stated that the issue with the lot lines should be resolved. Supervisor Krumrei will reach out to Mr. Leja and discuss how to proceed.
