- 5. Replacing volleyball net- Todd told Commissioners the net was old and broke. Lee stated he had one that should fit, and he will drop it off to replace the broken one.

Seth will be making large poster boards for Little Suamico Days and the Town Hall so the community can see what we're working towards for the park. Grants continue to be applied for. Penny has received around \$13,000.00 in grants for the park and is strictly a volunteer.
