**BUSINESS:**

1. Approve to place LS tractor on surplus auction and approval of funds to purchase new Town truck- Glinski went over what was discussed at the maintenance meeting as Tracey was at an appointment. Glinski stated maintenance would like to post the LS Tractor on the Wisconsin Surplus to get funds to purchase a new Town truck so that maintenance isn't using their own vehicles. Glinski went over that there is \$11,000,00 left for equipment purchases and Krumrei is requested to spend no more than \$20,000 on a new Town truck using the remaining balance and equipment purchases and possibly needing to take from the Money Market. Paape motioned that the LS Tractor can be placed on the Wisconsin Surplus approving funds needed for a new truck and if needed funds can come from money market, seconded by Pribyl. Approved by unanimous vote.
2. Review draft Ordinance proposals with Town attorney- Matt arrived at 9:15am to discuss edits and thoughts regarding the draft ordinance packet. Matt and the Town Board got through just under half of the book and scheduled the next meeting for April 9<sup>th</sup> from 8:30am-11am.
3. Town Board review draft Ordinance proposals from Ordinance Committee- Town Board had small discussion after the Town Attorney left. Paape stated she would update edits for the chapters that were discussed.
