BUSINESS:

1. Cross Road, South of Allen Road, culvert fail. Request for funding for replacement. Approve Disaster Damage Aids petition for grant dollars- Mohr went over the culvert failure for Cross Road and board went into deliberations. Krumrei motioned to \$5000-\$10,000 18' plastic culvert with end caps and be placed on the DDA (Disaster Damage Aids Petition), seconded by Scheffen. Approved by unanimous vote.
2. Bayside Road and Brown Road, culvert fail. Request for funding for replacement. Approve Disaster Damage Aids petition for grant dollars- Mohr went over the culvert failure and board went into deliberations. Krumrei motioned to approve squash pipe with end walls to not exceed \$25,000.00 and place on DDA (Disaster Damage Aids Petition), seconded by Pribyl. Approved by unanimous vote.
3. Approve Disaster Damage Aids petition for Lower Road, culvert fail- Mohr went over submitting Lower Road culvert to the DDA (Disaster Damage Aids Petition) and board went into deliberations. Pribyl approved to submit the culvert, seconded by Scheffen. Approved by unanimous vote.
