BUSINESS:

1. Approve mileage policy document and discuss an employee handbook- Dale Mohr discussed moving the town forward in creating clear documentation on having a number of policy statements on how we operate, as a Town Government, in order to have continuity throughout future turnovers and have everyone on the same page, while being fair, while protecting the Town and its employees. Ultimately, he stated we will have policies covering Personal Protective Equipment (PPE) and how we use volunteers or personal equipment as well, document and housed all within one handbook. It will be a requirement that all existing employees and the new hires read and sign acknowledging the policies set by the Town Board. Dale discussed past practices and went through the policy format steps to move the town forward with clear policies. Motion by Dave Pribyl to approve the Mileage Policies detailed in the Town of Little Suamico Mileage Reimbursement Policy (Dated May 13/2026) and to add them as part of an employee handbook for the Town, seconded by Helmle. Approved by unanimous vote.

2. Discuss and approve Road Projects for 2026- Motion by Pribyl to spend the 2026 State Transportation Aid money of \$278,057 and the Town's Budget line item of Construction of \$170,000 for roadwork in 2026, on the following road projects to be completed by Oconto County Highway, second by Helmle. Approved by unanimous vote.

- Herford RD, -Replace

- Foster DR, -Replace

- Wintergreen and Northernnaire DR, - Replace
